AMENDMENT TO RESTRICTIVE COVENANTS
Section I, Richmond Park of
Williamsburg Plantation

THIS AMENDMENT TO RESTRICTIVE COVENANTS, made this <u>Brd</u> day of <u>June</u>, 1997, by John Koenig and wife, Margarete Koenig, Owner of all that land designated and known as Section I, Richmond Park of Williamsburg Plantation; John Koenig, Inc., a North Carolina corporation with its principal office in Cumberland County, North Carolina, Developers; and the undersigned owners who desire to amend a portion of the Restrictive Covenants, recorded in Book 1339, Page 153, of the Onslow County Registry, and as shown on that certain plat recorded in Map Book 34, Page 63, of the Onslow County Registry.

WITNESSETH:

WHEREAS, John Koenig and wife, Margarete Koenig heretofore recorded Restrictive Covenants, Section I, Richmond Park of Williamsburg Plantation, in Book 1339, Page 153 of the Onslow County Registry; and

WHEREAS, said Restrictive Covenants as recorded aforesaid did not include compliance with storm water runoff rules provided by the State of North Carolina; and

WHEREAS, the undersigned now desire to amend said Restrictive Covenants to add a paragraph relating to said compliance.

NOW, THEREFORE, in order for the foregoing, the undersigned do hereby covenant and agree with all persons, firms, or corporations now owning or hereafter acquiring any portion of the real property described herein, that said real property shall be made subject to said Restrictive Covenants as follows:

26. STORM WATER RUNOFF: No more than 3,000 square feet to any lot shall be covered by structures, inclusive of rights of way, and/or paved surfaces, including walkways or patios of brick, stone, slate or similar materials. This covenant is intended to insure continued compliance with storm water runoff rules by the State of North Carolina and therefore benefits may be enforced by the State of North Carolina.

Except as modified as stated herein, the Restrictive Covenants for Section I, Richmond Park of Williamsburg Plantation are hereby ratified by each of the undersigned.
