Pursuant to General Statute Section 55A-2-02 of the General Statutes of North Carolina, the undersigned does hereby submit these Articles of Incorporation for the purpose of forming a nonprofit corporation.

- 1. The name of the corporation is BROOK RIDGE HOA, INC..
- The principal office address and county of the corporation is 121 Garnet Lane, Jacksonville, North Carolina 28546, Onslow County.
- The street address and county of the initial registered office of the corporation is 121 Garnet Lane, Jacksonville, North Carolina 28546, Onslow County. The name of the initial registered agent at this address is Jennifer L. Morton.
- The mailing address of the initial registered office is 121 Garnet Lane, Jacksonville, North Carolina 28546.
- The members of the corporation shall be the owners of the residential building lots in the residential subdivision of BROOK RIDGE, a Planned Residential Development in White Oak Township, Onslow County, North Carolina, described or to be described on a map or maps of said subdivision recorded in the Office of the Register of Deeds of Onslow County, North Carolina.
- The name and address of the incorporator is J. Dewey Edwards, Jr., 219 New Bridge Street, Jacksonville, North Carolina 28540.
- Upon dissolution of the corporation, all liabilities and obligations of the corporation shall be paid and discharged, or adequate provisions shall be made therefor, and the remainder of the corporation's assets shall be transferred and conveyed to the then individual owners of lots in the BROOK RIDGE subdivision described above, as may be expanded by annexation of additional sections, as tenants in common.
