The swimming pool will be open this year from Thursday, May 15th, 2025, through Wednesday, October 15th, 2025. To access the pool, all residents and guests over the age of 5 must complete the required forms and purchase a pool wristband, which you must have at all times while at the pool. Each individual requires a separate wristband. Once the completed form and payment have been submitted to Advantage Gold (via mail or in person), annual wristbands can be picked up at the Advantage Gold Realty office, located at 1512 Gum Branch Rd., Jacksonville, NC 28540. Alternatively, you may choose to pick up your wristband from one of the board members at the pool on May 3rd from 12:00 PM to 1:00 PM, provided payment has already been made.

Please note the following items:

The cost for pool bands is \$5.00 per bracelet.

Ages six (6) and up are required to wear a pool band when using the pool and no child under the age of 12 is permitted without an adult.

Entrance into the pool area will be through the gate card assigned to your unit.

The gate card for your unit will not be activated for the pool unless at least one (1) band is purchased. Homeowners must be current on their HOA dues to receive their pool bands.

If pool violations, theft and/or destruction occur, individuals will be liable for the damage caused.

By signing below, I agree to ensure my group abides by the following POOL RULES:

- 4.1 Swim at own risk as no pool lifeguard is on duty
- 4.2 Pool hours are 8am to dusk daily.
- 4.3 Residents must accompanyguests
- 4.4 Children under the age of 12 must be accompanied by an adult
- 4.5 Pool access is via the same gate card used for the entrance gate
- 4.6 Pool pass bracelets must be worn while in the pool area. The bracelets will be changed annually for \$5 each.
- 4.7 Audio devices must be used with headphones
- 4.8 Glass is not permitted in pool area by local ordinance
- 4.9 No alcoholic beverages in pool area
- 4.10 Food is not permitted in pool area
- 4.11 Pets are not permitted in the pool area by health law
- 4.12 Smoking/tobacco products are not permitted in the pool area
- 4.13 Chairs have been provided for your use around the pool. Please use these at your own risk. No chairs are permitted inside of the pool itself.

Please stay safe and vacate the pool area by dusk as there is not adequate lighting to allow for night swims.
